RESOLUTION SBPC #1730-06-17

A RESOLUTION SUPPORTING THE PARISH PRESIDENT'S REQUEST OF PLAQUEMINES PARISH AND/OR THE STATE OF LOUISIANA TO CLOSE MARDI GRAS PASS ON AN EMERGENCY BASIS.

WHEREAS, St. Bernard Parish and its citizens have suffered tremendously as a result of the catastrophic coastal land and wetlands loss, and natural resources loss to Coastal St. Bernard Parish as a result of man-made and/or natural disasters;

WHEREAS, St. Bernard Parish and Plaquemines Parish are experiencing catastrophic destruction and loss of oyster beds and fisheries caused by fresh water from the Mississippi River flowing through the Mardi Gras Pass into the waterways of Coastal St. Bernard Parish and Coastal Plaquemines Parish;

WHEREAS, the Governor of the State of Louisiana has already declared a state of emergency for Coastal Louisiana, which includes St. Bernard and Plaquemines Parishes;

WHEREAS, the St. Bernard Parish Council declares its support for the Parish President formally requesting that the State of Louisiana and Plaquemines Parish close Mardi Gras Pass on an emergency basis.

NOW THEREFORE, BE IT RESOLVED, that the St. Bernard Parish Council, the governing authority of St. Bernard Parish, does hereby declare its support for the Parish President formally requesting that the State of Louisiana and/or Plaquemines Parish close Mardi Gras Pass on an emergency basis.


