

____1. Completed application form. 2. Copy of recorded property titles. Contact St. Bernard Parish Clerk of Court at (504) 271-3434. 3. Three (3) sets of dated, site-specific original and sealed plans drawn up by a Louisiana Registered architect or civil engineer to include the following: Material specifications dated and labeled. a. Site plan dimensioned to scale, showing all existing and proposed structures, yard b. setbacks, servitudes, parking spaces, surrounding street names, square and lot number, and subdivision name. C. Total square footage of structure. North, South, East and West elevation sketches. d. Dimensioned floor plan, including locations of electrical outlets and lights, and e. plumbing facilities. Typical interior and exterior wall and window details. f. Foundation plan. g. Original landscape plan prepared by a Louisiana Licensed Landscape h. Architect and shall bear the Landscape Architect's seal and signature. All landscape plans shall contain a statement signed and dated by the preparer certifying that the plan was prepared in accordance with Louisiana Horticulture Law and specifications. 4. For structures with a footprint of 5,000 square feet or more, or any improvement, including parking, a drainage plan and associated calculations must be submitted for the purpose of obtaining a drainage permit from St. Bernard Parish Government, Department of Public Works at (504) 278-4300. 5. Copy of property survey or if none exists, copy of titles accompanied by item in 3-b listed above, must be submitted.

GENERAL REQUIREMENTS

All electrical, plumbing, gas and mechanical work must be filed by a St. Bernard Parish licensed electrician, plumber, gasfitter and mechanical contractor. The work must be inspected and approved before any finals are issued. All inspections must be scheduled with the Department of Community Development (504) 278-4310.

<u>All new signage requires a permit</u> issued by the Department of Community Development (504) 278-4310 prior to installation.

<u>A Zoning Compliance Letter must be issued</u> from the Department of Community (504) 278-4310 prior to obtaining an Occupational License from the St. Bernard Parish Sheriff's Office (504) 271-2504.

Alcohol and Beer licenses may be applied for through St. Bernard Parish Government, Alcohol, Beverage and Bingo Permits at (504) 278-4327 prior to serving alcohol and beer.

Any contractor or party who intends to do work that may affect changes to the subsurface within 1,500 feet of the Lake Borgne Basin Levee District (LBBLD) Mississippi River flood control structure or within 300 feet of the toe of all hurricane protection structures are required to apply for a permit from the Lake Borgne Basin Levee District (LBBLD).
