AN ORDINANCE AUTHORIZING THE SALE AND PUBLIC AUCTION OF SURPLUS ROAD EQUIPMENT.

ST. BERNARD PARISH COUNCIL DOES HEREBY ORDAIN:

WHEREAS, the St. Bernard Parish Council authorizes and approves the public auction held on May 5, 2014 which sold surplus Road Department equipment;

WHEREAS, said auction was publicly advertised via public notice April 25 and May 2, 2014 in the St. Bernard Voice;

WHEREAS, the equipment listed in Exhibit "A" was surplus and not needed for a public purpose.

SECTION 1. St. Bernard Parish Council the governing authority for St. Bernard parish does hereby authorize the Road Department to hold a public auction for all items listed in Exhibit "A" in accordance with Louisiana Revised Statute 49:125.

SECTION 2. Effective Date. This Ordinance shall become effective immediately upon authorizing signature by the Parish President. In the event of a presidential veto, this Ordinance shall become effective upon a two-thirds favorable vote of the total membership of the Council pursuant to Sections 2-11 and 2-13 of the St. Bernard Parish Home Rule Charter.

SECTION 3. Severability. If any section, clause, paragraph, provision or portion of this ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect any other section, clause, paragraph, provision or portion of this Ordinance, the St. Bernard Parish Council
