A RESOLUTION APPROVING LOCAL MATCH FUNDING TOWARDS HURRICANE ISAAC GRANTS UNDER THE COMMUNITY DEVELOPMENT BLOCK GRANT DISASTER RECOVERY PROGRAM AND FEMA HAZARD MITIGATION GRANT PROGRAM IN THE AMOUNT OF \$561,015.00 TO SUPPORT THE JEAN LAFITTE PARKWAY DRAINAGE PROJECT

WHEREAS, the Parish applied in October, 2013 for a grant under the Hurricane Isaac Hazard Mitigation Grant Program in the amount of \$1,455,610.00 to help fund approximately 75% of the Jean Lafitte Drainage Improvement Project; and

WHEREAS, the Parish is pursuing funding of this same project from the Federal Emergency Management Agency under the Hurricane Katrina Disaster Recovery Program (with 100% funding) but has yet to receive such funding; and

WHEREAS, the Office of Community Development has made available funding in the amount of \$150,000.00 through the Louisiana Community Development Block Grant Disaster Recovery Program to assist St. Bernard Parish, impacted by Hurricane Isaac, in implementing ongoing and planned recovery projects and the Parish submitted an application to utilize this \$150,000 in funding in April, 2014; and,

WHEREAS, the Office of Community Development requires that St. Bernard Parish Council acknowledge it is committed to providing the local matching funds necessary to complete the Jean Lafitte Drainage Project estimated at \$561,015.00 (approximately 25% of the total cost) as part of this application process; and,

NOW THEREFORE BE IT RESOLVED, that the St. Bernard Parish Council, does hereby certify by this resolution its commitment and proof of approval for local matching funds in the amount of \$561,015.00 to complete the Jean Lafitte Drainage


The Council Chair, Mr. McInnis, cast his vote as **YEA**.
