WHEREAS, the St. Bernard Parish Council, does hereby allow the hiring of a Bus Driver for the Transit Department of St. Bernard Parish.

NOW THEREFORE BE IT RESOLVED, the St. Bernard Parish Council, the governing authority of St. Bernard Parish, does hereby authorize Administration to finalize the hiring to fill the vacant position of Bus Driver in the Transit Department.
