RESOLUTION SBPC #1322-04-15

A RESOLUTION AUTHORIZING A GRANT APPLICATION TO THE LOUISIANA OFFICE OF COMMUNITY DEVELOPMENT FOR REDEVELOPMENT OF BLUEBIRD PARK IN THE AMOUNT OF \$300,000.00.

WHEREAS, there are limited recreational opportunities available for special needs children and their families in St. Bernard Parish at the present time; and,

WHEREAS, the existing neighborhood park known as Bluebird Park on E. Chalmette Circle in Chalmette has not been properly restored from hurricane damage and is underutilized in its present condition; and,

WHEREAS, St. Bernard Parish is seeking grant funding to redevelop Bluebird Park with an emphasis on recreational facilities for special needs children and their families; and,

WHEREAS, the Louisiana Office of Community Development has indicated it has funding available which is suitable for this purpose.

NOW THEREFORE BE IT RESOLVED the St. Bernard Parish Council, does hereby authorize the submission of a grant application to the State of Louisiana Office of Community Development for Redevelopment of Bluebird Park in the amount of \$300,000.00; and,

BE IT FURTHER RESOLVED, the St. Bernard Parish Council does hereby authorize the President of St. Bernard Parish Government to sign and submit all required grant applications, Cooperative Endeavor Agreements and any amendments thereof, and all of the necessary reports, assurances, contracts and any other documents required in connection with this grant program.
